 - 2. **Scott & Catherine Klose (Owner & Applicant)** Request for a variance from Article III, Section 275-22.A and Table 1, Table of Dimensional Regulations, to permit a 205 square foot shed to be located 6.9 feet from the side yard property line where 25 feet is required at 4 Servant Street, Lot 44-25, Zoned GR.

 - 6. **Order of St. Benedict of NH (Owner & Applicant)** Request for a variance from Article IV, Section 275-27.A to permanently fill 12,122 square feet and temporarily fill 578 square feet of wetland for the construction of a Track and Field Athletic Complex for Saint Anselm College at the corner of Rundlett Hill Road and Worthley Road, Lot 42-62-01, Zoned GR.
